

## **Artist Rights Watch Podcast: Standard License Terms**

By downloading the digital content file(s) ("ARW Podcast") you agree to be bound by the terms set out below ("the License")

### **1. License**

Subject to the terms of this License, Artist Rights Watch ("ARW") grants you a non-exclusive license to download the ARW Podcast for a period of thirty (30) days from the date of posting which shall be deemed to be the date included in the file name as hosted by ARW on one (1) or more of its servers or servers maintained by a third party.

### **2. Use of ARW Podcast**

2.1 THE ARW PODCASTS ARE FOR YOUR PERSONAL NON-COMMERCIAL USE ONLY. YOU MAY NOT COPY, REPRODUCE, REPUBLISH, POST, BROADCAST, TRANSMIT, LINK TO, MAKE AVAILABLE TO THE PUBLIC, SELL OR OTHERWISE RE-USE OR COMMERCIALIZE THE ARW PODCAST, OR ANY PART OF THE ARW PODCAST, IN ANY WAY WITHOUT THE PRIOR WRITTEN CONSENT OF ARW IN EACH INSTANCE.

#### **6. Termination**

All transmissions of ARW Podcasts are governed by Georgia law and the copyright laws of the United States, without giving effect to the conflict of law provisions of Georgia law.

7.3 Any failure or delay by either party in exercising its rights under any provisions of this Agreement shall not be construed as a waiver of those rights at any time now or in the future.

7.4 This Agreement constitutes the entire agreement between you and ARW and governs your use of the ARW Podcasts, superseding any prior agreements between you and ARW, if any.
